NOTIFICATION

After careful consideration of the Memorandum of Association and Rules and Regulations of the aforesaid Federation forwarded to this end, the Governor is pleased to accord approval to the formation and registration of the aforesaid Federation.

2. The Governor is also pleased to direct that the aforesaid Federation will make consistent efforts so that all the Poultry Producers in the State comes within its fold as soon as possible.




