

NOTICE INVITING TENDER

Sealed tenders are invited through hand or by post to the Managing Director of Bengal Poultry Products Marketing & Bio Security Management Pvt. Ltd. which is a sister concern of West Bengal Poultry Federation which deals with purchase & supply of poultry products to the State Government. We are seeking tender applications from bonafyed and experienced live ready broiler bird producers of West Bengal for supplying live ready broiler birds. All the terms & conditions mentioned below are applicable for both the district locations. Please follow the location details and terms & conditions as mentioned below for submitting the open tender for two different places namely:

- A. Haringhata, Dist: Nadia,
- B. Phasidawa, Siliguri, Dist: Darjeeling.

- The body weight of all the supplied live ready broiler birds should be within:

(i). 1100 gm. to 1300 gm. (Base price + Rs. 15.00)

(ii). 1500 gm. to 1799 gm. (Base price + Rs. 5.00)

(iii). 1800 gm. to 2200 gm. (Base Price)

-Rest birds of below or above mentioned weight will not be accepted.

-L1 (Lowest Bidder) will be selected based on the lowest rate as quoted for item-(iii) and he will also be Bound to supply item-(i) and item-(ii) as per the mentioned quantity & price.

- The participants of the tender have the independency to submit tender applications either for one single district or for both the districts together.

Live ready broiler birds should be supplied healthy and must be free from restricted medicines.

- The placed orders must be delivered at the delivery point strictly on time and for multiple vehicles, the delivery time will be as- 1st vehicle between 05.30 A.M. to 06.30 A.M., 2nd vehicle between 09.00 A.M. to 09.30 A.M. & 3rd vehicle between 10.00 A.M. to 10.30 A.M in both the districts.
- The delivery point of the consignments will be in two different districts namely Haringhata, Dist: Nadia and Phasidawa, Siliguri, Dist: Darjeeling.
- It is to keep in mind that as per our average requirement, the approximate weekly & monthly consignment will be as mentioned below:-
 - A. Haringhata, Dist: Nadia - Minimum 50 tons & maximum 60 tons weekly, hence minimum 200 tons & maximum 240 tons monthly.
 - B. Phasidawa, Siliguri, Dist: Darjeeling - Minimum 15 tons & maximum 25 tons weekly, hence minimum 60 tons & maximum 100 tons monthly.
- The total weight of the supplied consignment will be recorded and billed as per the certification of the West Bengal Livestock Development Corporation Ltd on our challan documents.
- Opting any unethical ways in the vehicle to increase or extend the weight of live ready broiler birds are strictly prohibited and if found so, the decision of the WBLDC at both the delivery points will be final and unchanged.

- Dead birds will not be accepted on any circumstances at both the delivery points.
- Payment of the bills will be released within 21 working days from the date of submission of the bills. An additional 10 working days will be kept for release of payment due to any unavoidable circumstances.
- Please submit your rate quotes including all your transport, delivery & other miscellaneous charges.
- If the selected vendor stops the supply of live ready broiler birds suddenly in between the term of contract due to hike in market rate, then 50% of the total billing amount will be deducted as penalty charges for breaking the norms of the contract.
- At the receiving end, on spot tare weight will be final and accepted & no outside tare weight will be entertained.
- Time of delivery of ready live broiler birds (from morning 05.30 AM onward) to the receiving end to be maintained strictly. Delayed delivery of the same may be returned by the receiving authority.
- Applications will be accepted only from the member organizations of West Bengal Poultry Federation.
- The contract of the tender will be valid for one whole year from 1st April, 2019 to 31st March, 2020.
- Applications for tender will be accepted with enclosed valid documents like (i). Trade License Copy, (ii). Present capacity of Bird Production with due proof for last 1 year, (iii). Should produce the Membership Code of WBPF as allotted.
- As per the selection/bidding particular date the applicant or his/her representative must be present at the bidding venue otherwise his/her tender application may be liable for rejection.
- Wet birds (spraying water or due to rain) will not be accepted during delivery and if any other means are used to increase the weight of the vehicle at the delivery point will be rejected by the sole decision of WBLDC.
- After delivery of the birds, while dressing if found any damage on the body of the birds, then it may be rejected by WBLDC and it must be accepted by the supplier.
- The management of the Bengal Poultry Products Marketing & Bio Security Management Pvt. Ltd. reserves the full right for selection & rejection of the submitted Tender Applications.
