NOTIFICATION

In exercise of powers conferred by Sub-Section 1 (a) of Section 2 of West Bengal Agricultural Produce Marketing (Regulation) Act, 1972, (W.B. Act XXXV of 1972), (hereinafter referred to as the said Act) the Governor is hereby pleased to exclude total 7 (Seven) Items under the Categories 'Cereals', 'Oil Seeds', 'Animal Husbandry Products' and 'Miscellaneous' at Serial No. I, III, VIII & XII respectively in the Schedule appended to the said Act as given in the Table below.


